

# **2016 MTA RETIRED GATHERING**

Honoring a colleague — and her activism

The 15th annual Retired Members Gathering honored longtime MTA activist Gladys Durant, who died in June. And the gathering itself reflected her can-do spirit, as numerous retired members committed to participating in the campaign to defeat Question 2.

The event, held Sept. 28 at the Sheraton Framingham Hotel and Conference Center, also offered workshops and social opportunities, along with updates from MTA leadership.

Retired Members Committee Co-Chairs Kathleen Roberts and Richard Liston welcomed the hundreds of attendees, who in turn gave Roberts a standing ovation in recognition of her recent 102nd birthday.

Liston addressed the attendees, saying, "While we may have left our classrooms, we never left this profession — and I know you are all committed to our active members and our public school students as well."

He highlighted a new mentoring initiative between retirees and the Student Educators Association of Massachusetts, or SEAM, and he commended the success that retirees achieved in gathering signatures last year to move the Fair Share Amendment toward the ballot in 2018. The amendment would raise revenue for public education and transportation through an additional 4 percent tax on annual income over \$1 million.

Liston urged his fellow retirees to be involved in the Save Our Public Schools campaign to defeat ballot Question 2, which seeks to lift the cap on charter schools. Many heeded the call by signing up for various actions and picking up "No on 2" yard signs to display in their neighborhoods.

"There is a lot of rhetoric being presented by charter school proponents," Liston said. "But Massachusetts public schools are the best in the country. That's because we did a good job. We made a difference in the lives of so many students, as our active teachers currently do, and our future teachers, with our support, will continue to do."

MTA Vice President Erik J. Champy applauded the retirees, telling them, "We stand on your shoulders. You fought the fights that have been so important to educators and students." Further, Champy acknowledged many individuals at the gathering for nurturing his path to leadership.

MTA President Barbara Madeloni praised the professionalism of the retirees, calling them and active educators "experts in our field."

In opposing Question 2, she said, "we have an amazing opportunity to be leaders in protecting public education."

Executive Director-Treasurer Ann Clarke wore two hats — literally — as she addressed the crowd.

First she donned a "Save Our Public Schools" cap to emphasize the MTA's commitment to the No on 2 campaign. Then, as the audience applauded, she took off that hat and put on a cap bearing the trademark "H" of the Hillary Clinton presidential campaign. Clarke noted the importance of both defeating the ballot question and making sure that Clinton prevails over Donald Trump in the election.

Presentation of the Honor Our Own award is a highlight of the gathering each year. Typically, the Retired Members Committee solicits nominations. But this year the committee itself decided to recognize Durant, who died June 4 at the age of 75.

Durant taught for more than 30 years in the Attleboro Public Schools and remained active in both her local association and the MTA throughout retirement. "She was one of a kind, a force of nature," Liston said.

Durant's son, Michael, accepted the award and described his mother as someone who was passionate about social justice and education.

"Whenever there was an election, she made sure we knew how important it was to vote," he said, adding with a laugh: "And my mother always made sure we knew whom or what to vote for."

Durant was an active member of the Retired Members Committee at the time of her death. She held other leadership positions in the MTA and had received the Honor Our Own award in 2010.

A couple of annual attractions were in full swing again this year. Mary Gilmore, a former MTA president, was stationed once again at a table featuring a fund-raising raffle for the Voice of Teachers for Education.

Another staple of the event is the donation of school supplies to a district with a high level of need. This year, attendees donated several boxes' worth to the Southbridge Public Schools.

# **ELECTION OPPORTUNITIES FOR MTA RETIRED MEMBERS**

## An overview

ur union's strength comes from full participation of all members, including retirees, in MTA and NEA election processes at the local, state and national levels. Please consider the following opportunities to engage the democratic processes of our union. Share with other retirees, and let's grow union power.

The election and nomination process for all of the seats described here are subject to MTA Bylaws and to MTA Policy/Procedures for Nominations and Elections, all of which is available upon request from the MTA Division of Governance.

## Statewide Retired Region Executive Committee Member

The Executive Committee seat representing the Statewide Retired Region will be up for election. The Executive Committee, along with the Board, is a governing body of MTA, with various responsibilities including real estate, finance, and personnel oversight and decision-making. Executive Committee members automatically also serve on the MTA Board of Directors. Terms are for three years, beginning July 1, 2017. Candidates must be members of the Statewide Retired District. There is a self-nomination process, with a deadline of March 3, 2017. The election will take place at the 2017 MTA Annual Meeting of Delegates, voted on by the delegates representing the Retired District.

Those wishing to run for this seat should submit a selfnominating letter no later than 5:00 pm on the first Friday in March, specifying the candidate's name and address and the office being sought. The letter should be addressed to Executive Director-Treasurer, MTA, 2 Heritage Drive, 8th Floor, Quincy, MA 02171-2119, and may be faxed to 617-570-4908 or emailed to *MTAGovernance@massteacher.org*.

## MTA Retired Delegates to the NEA Representative Assembly (NEA-RA)

The 2017 NEA Representative Assembly will be held July 2 through July 5, in Boston. (Required attendance begins with the first caucus on June 30 at 9:30 am.)

The NEA-RA is the meeting of representatives from all NEA state associations. At this meeting, policies are voted on and set regarding a range of issues critical to educators from testing to economic and racial justice, to electoral politics, and more. It is an opportunity for democratic

engagement and making national connections to build our movement and strength.

Elected delegates are also strongly encouraged to attend the NEA-Retired Annual Meeting, taking place immediately before the NEA-RA in Boston. Information will be sent to the delegation at a later date, and MTA will reimburse additional hotel and food costs for attending this meeting.

NEA will allocate the number of retired delegate seats to the NEA-RA for Massachusetts. Nominations are open to all eligible MTA/NEA retired members through a selfnomination process. These delegates will be elected by a ballot sent to all NEA retired members in March.

MTA provides funding to the winners of the MTA Statewide, Regional, and Retired elections to the NEA-RA, subject to accountability requirements (\$1200 stipend per delegate).

## **MEDICARE UPDATE**

The Social Security Administration recently announced that, in 2017, beneficiaries will receive a costof-living adjustment of 0.3 percent. But about 70 percent of beneficiaries will not see any increase in their Social Security benefits because every dollar of the increase will go to pay for higher Medicare premiums. What will happen to the other 30 percent of beneficiaries depends on the mood of the Congress.

Typically, the Medicare Part B premium is increased each year in line with Part B per capita expenditures. In the absence of any complicating factors, the 2016 monthly premium would have increased from \$104.90 in 2015 to \$120.70. The law, however, contains a "hold harmless" provision that limits the dollar increase in the premium to the dollar increase in an individual's Social Security benefit. Because the COLA for Social Security benefits was zero for 2016, premiums

did not increase for the 70 percent of beneficiaries protected by the hold harmless provision and they continued to pay \$104.90.

Although the Medicare Part B premium has not been officially announced for 2017, at the time of this writing, reports suggest that, if the hold harmless provision did not apply, the premium would be about the same in 2017 as in 2016 – that is, about \$120. Beneficiaries protected by the hold harmless provision, however, will see their Medicare Part B premium go up only by the dollar increase in their Social Security benefit.

The really interesting question is what's going to happen to the 30 percent of beneficiaries not protected by the hold harmless provision. These include new enrollees during the year (5 percent); enrollees who do not receive a Social Security benefit check (3 percent); enrollees with high incomes, who are subject to the income-related premium adjustment (6 percent); and dual Medicare-Medicaid beneficiaries, whose full premiums are paid by state Medicaid programs (19 percent). (Some overlap exists between the categories, which explains why the numbers add up to slightly more than 30 percent.)

In 2016, the unprotected group faced increases as high as 50 percent, in part to make up for what the protected 70 percent weren't paying. But in October last year, Congress and the President agreed on a two-year budget deal that held the increases to 16 percent in 2016. So the basic premium for the unprotected group rose to \$121.80, and much higher for those with income-related premiums. But the protection technically would apply to 2017 only if it were another year of zero Social Security COLA. Who knows what will happen in the face of a very small COLA. ■
